4 PAWS PET POLICY

We have thoughtfully put the following policy in place for the comfort of you, your treasured pet, and for the comfort of our other resort guests. Please familiarize yourself with our pet policy, and agree to our terms and conditions.

POLICY:

- Dogs and Cats are the only permitted pets on property.
- We have a weight restriction for your pet of 75 lbs for a maximum of two pets. If your pet exceeds this weight, we will not be able to welcome them to the resort.
- Additional fees may apply if your pet causes any damage or disturbances in the room or hotel
- Your dogs must be crated if alone in the room
- We can provide a list of pet sitting services through the Guest Services Department
- Please utilize the Bark Park for your pet's exercise and relief needs

TERMS AND CONDITIONS (please initial next to each statement below)

- _____ I agree that I have traveled with the proper leash or crate for my pet(s). My pet(s) will be on a leash or in a crate when outside the guest room.
- _____ I understand and agree that if I request service, I will be present with, or remove, the pet(s) from the room. If I remain present, my pet(s) will be crated while the room is serviced by housekeeping or any department.
- _____ I understand and agree that I am to dispose of all pet waste, or debris, and will notify the hotel immediately about any pet "accidents" that may require cleaning.
- _____ I understand and agree that I am to keep my pet(s) on floors designated for pets and in pet-friendly rooms.
- _____ I understand and agree to that my pet(s) are not permitted in the fitness center, pool, golf course, meeting room, restaurant or bar areas unless the pet(s) is a service animal.
- _____ I understand and agree to that should the hotel determine that the pet is objectionable to other hotel guests, I must immediately make other arrangements to house the pet outside of the hotel.
- _____ I understand and agree to indemnify and hold harmless Lansdowne Resort and Spa, it's operator and owners, and their respective affiliates, from all liability and/or damage suffered as a result of my pet(s).
- _____ I understand that I am responsible for all personal injuries and/or property damage related to my pets(s).
- _____ I understand if my pet is left unattended and responsible for disturbing other guests , a \$20 per hour "time out" fee is assessed by Lansdowne Resort and Spa, if a pet needs to be removed from a guestroom.
- _____ I understand the 4Paws rate for pets is \$100 non-refundable per pet per room up to six nights and \$150 for up to 2 pets per room. \$200 additional non-refundable deep-cleaning fee from day seven - day 30.
- _____ Amenity of bed, bowl and matt in guestroom is for pet use during their stay only. Pet amenities available for purchase, unless included on the Pet Friendly Package.
